- Provide input into the overall Category strategy about segmentation and identification of key supplier relationships, support the implementation of procurement category related activities on a timely basis in line with the targeted goals.
- Manage strategic category or sub-category supplier relationships, and implement consistent key performance indicators, ensuring that supplier performance risks and issues are identified and resolved on a timely basis,
- May directly control at a country level purchase with respect to supplier choice, timing and commercial conditions (may vary between divisions depending on way spend is controlled) and collect supplier information and feedback from Divisions, countries, sites, Category teams and Business Partners, and deliver Procurement Balanced Scorecard metrics for the relevant subcategory
- Support contract management activities for major contracts for the category/sub category, and ensure that negotiated contracts are clearly communicated to involved parts (business owners and supplier) and that commercial conditions are consistently reflected in Novartis systems.
