Ensure adherence and compliance of toll manufacturing inventory reporting/reconciliation and related operational activities (e.g. write-off booking, BOM maintenance, consumption of FOC component, PO adjustments).

- Delovati kot kompetenten sogovornik med dodeljenimi strankami in različnimi funkcijami, da zagotovite visoko raven storitev za stranke. Zagotavljanje izboljšane ravni znanja o procesih in SAP (usklajevanje cestnin in CMO poslovanje) ter deluje kot protitutež ERP BPM
- Izvajanje dnevnih rutinskih bilanc in poročil o usklajevanju v skladu s pravili SOX in NFCM za vsako proizvodno mesto; ugotavlja, izpodbija in rešuje neskladja v inventarju. Izvajajte mesečno poročanje in usklajevanje cestninjenja, prepoznajte težave za prihodnje ukrepanje.
- Tesno sodelovanje z NTO BPA Izračun stroškov in zalog izdelkov ter zagotavljanje analiz in utemeljitev odstopanj v proizvodnji cestnine, ki vplivajo na merilo uspešnosti COGS in NTO. Zagotovite pravilno rezervacijo dostav in porabo brezplačnih komponent.
- Podpora dobaviteljem vračila komponent FOC; Aktivno podpirajte prodajalce cestnin pri razumevanju in sledenju procesom, povezanim z usklajevanjem cestnin in reševanjem vprašanj usklajevanja.
- Delovati kot SPOC za BPA SCM, BPA TechOps in BPA/Materials Management v obratih za vprašanja, povezana s cestninsko proizvodnjo. zagotoviti, da so na voljo ustrezna orodja (poročanje in analitika) za odkrivanje trendov, ki bi lahko vplivali na stroške, in rezultate, z namenom izvajanja proaktivnih preventivnih ukrepov.
- Sodelujte z vodjo oskrbe API v primeru vprašanj v zvezi z dobavo in/ali proizvodnjo/usklajevanjem cestnine. Spremljajte in vzdržujte pravilne sistemske transakcije, povezane s procesi E2E, ki se začnejo z ustvarjanjem naročila do dostave strankam CMO.
- Pripravite in zagotovite razpoložljivost vse ustrezne dokumentacije in odobritev za stranke CMO (npr. Račun ...). Delovati kot enotna kontaktna točka za vprašanja stopnjevanja za dodeljene stranke in lokacije CMO, vplivati in povezovati ustrezne zainteresirane strani za pospešitev (sistemskega) reševanja težav.

- Manage enhanced level of E2E responsibility and team support from smooth transactional execution between Donation/Divestment third party customers and respective suppliers & ESO CMO Vendors to all logistics matters, including material movement from production sites to third party customers.
- Act as a competent counterpart between assigned customers and various functions to guarantee high customer service level. Provide an enhanced level of Process and SAP knowledge (Tolling reconciliation and CMO business) and acts as counterpart to ERP BPM
- Perform daily routine Reconciliation balances and Reports in compliance with SOX and NFCM rules for each manufacturing site; identifies, challenge and solve inventory

discrepancies. Perform monthly Toll-Manufacturing reporting and reconciliation, identify problems for future action.

- Close collaboration with NTO BPA Product costing & inventory and provide analyzes and justification on toll production variances impacting the COGS and NTO performance measure. Ensure correct booking of deliveries and consumption of free of charge components.
- Support vendor returns of FOC Components; actively support toll vendors in understanding and following the processes related to toll reconciliation and resolving reconciliation issues.
- Act as SPOC for BPA SCM, BPA TechOps and BPA/Materials Management at the Plants for Toll manufacturing related issues. Assure that adequate tools (reporting and analytics) are available to detect trends that could impact costs, and results with the view to implement proactive preventive actions.
- Collaborate with the API Supply Manager in case of questions related to supply and/or toll manufacturing/reconciliation. Monitor and maintain correct system transactions related to E2E processes started by order creation till delivery to CMO customers.
- Prepare and ensure availability of all relevant documentations and approvals for CMO customers (e.g. Invoice...). Act as single point of contact for escalation issues for assigned CMO customers & sites, influencing and connecting relevant stakeholders to speed up (system) issue resolution.

- Higher education (bachelor ' s degree) in Finance, Supply Chain Management or Business Administration
- At least 3-5 years of experience in Supply Chain processes, incl. customer service and vendor management. Experience of freight forwarding material movement within Supply Chain
- Previous experience with Manufacturi and booking processes and systems desired
- Advantage knowledge in Project Management, ideally in a cross-functional project
- Well structured, strong conceptual thinking and process-orientation, willing to expose issues and work collaboratively across functions to put in place systemic solutions that address root cause and deliver on expected timelines
- Deeper SAP knowledge desired
- Strong analytical, problem-solving and critical thinking skills
- Fluent written and spoken knowledge of English
