- Lead incident and near - miss reporting, coordinating investigations and root cause analysis
- Drive CAPA implementation, tracking progress and promoting continuous HSE performance improvement
- Perform and update machine, chemical, biosafety, and other risk assessments; maintain the risk register
- Deliver HSE training, toolbox talks, and provide expert guidance to managers and teams
- Ensure compliance with environmental requirements, including waste, emissions, and chemical storage; support process safety evaluations
- Manage timely HSE reporting, KPI submission, and sharing of lessons learned and best practices across the organisation

- Strong background in Belgian HSE regulations, environmental permitting, and EU directives.
- Demonstrated experience in incident investigation, risk assessment, operational HSE support, HSE by design project management
- Familiarity with aseptic manufacturing operations and process safety principles.
- Ability to work in a highly regulated, fast - paced operational environment.
