- Support ME/HCP education activities, including hospital staff meetings, regional scientific events, symposia, and internal or external educational initiatives.
- Systematically collect, synthesize, and communicate actionable external insights from clinical practice, scientific discussions, and competitive activities to inform local and regional medical strategy.
