This role partners with business, product, architecture, and engineering teams to transform emerging AI capabilities into validated solutions that can be industrialized by the Agentic Factory.

- Design and implement prototype solutions using LLMs, multi-agent frameworks, RAG, orchestration platforms, and modern AI tooling.
- Collaborate closely with AI Architecture, Product, and Engineering teams to transition successful PoCs into production roadmaps.
- Establish repeatable methodologies, evaluation criteria, and technical documentation for AI experimentation.
- Assess emerging AI technologies and recommend new capabilities for inclusion in the enterprise AI roadmap.
- Mentor AI engineers and foster a culture of experimentation, rapid learning, and innovation.
